### Official Information Act Request

Thank you for your request of 13 December 2024, under the Official Information Act 1982, for the following information:

*Can you please provide me with a list of the Māori PTE's in New Zealand, each year for the last five calendar years? The progressive decline in the number of Māori PTE's is cause for concern, and we are interested to learn more about why that might be*

Your request has been considered under the Official Information Act 1982.

I include the following information covered by your request:

There are a total of 31 Māori providers as of 17 January 2025, which includes 3 Wānanga and 28 PTEs. Over the previous 5 years there has been a decline of 5 Māori providers. Please note that for the purpose of this response we have defined 'Māori providers' to mean those organisations who receive quality assurance services from NZQA's Quality Assurance Māori business unit.
